The course presents the ISO 14001:2015 standard in a concise, practical format, allowing learners to understand what is required for successful EMS implementation and management.

- ISO 14001:2015 requirements & Annex SL
- EMS terminology and key definitions
- Organisational context and stakeholder analysis
- Leadership responsibilities under the standard
- Identification and management of environmental aspects
- Legal compliance and regulatory expectations
- EMS policy and integration with company strategy
- Required documentation and records
- Internal communication and employee engagement
- EMS auditing, reviews and continuous improvement
- Emergency preparedness and response
- The role of third-party certification bodies
