## What's covered?

Element 1 – Foundations of environmental awareness

- Meaning of key environmental terms
- Sustainability
- Components and certification of an environmental management system

Element 2 – Pollution, impact assessment and emergencies

- Principles and practice of risk assessments
- Air, water and land pollution
- Environmental noise
- Waste management
- Environmental emergencies

## Who should participate?

This course will be of interest to all personnel who need to understand the interaction between their company, its environmental management system and the environment.

## What will I learn?

Participants achieve the following learning outcomes from the programme;

- Identify the meaning of: the environment, weather, climate, habitats, ecosystems, biodiversity, pollution, sustainability
- Identify the importance and benefits of sustainable development
- Identify an environmental management system's main components and the certification process
- Outline the principles and practice of impact (risk) assessments
- Identify the main sources, types, controls and impacts of air pollution
- Identify the main sources, controls and impacts of water pollution
- Identify the main sources, controls and impacts of environmental noise
- Identify waste types
- Identify the waste hierarchy and ways to effectively manage waste
- Outline the measures that need to be in place when dealing with emergencies

## How will I be assessed?

Certificate students need to register with a NEBOSH approved centre to sit their exams. (SQT is a NEBOSH Approved Centre 551).

The assessment process for delegates consists of an online multiple choice examination that will take 30 minutes. Delegates must achieve a pass in the examination paper to be awarded the NEBOSH Award in Environmental Awareness at Work.

The multiple choice assessment must be accessed and completed via NEBOSH's Online Assessment Platform and completed within a 24-hour assessment window. Learners can begin their assessment at any time within the 24-hour window but, once they have started the assessment, they must complete it within the designated time frame for the unit. These assessments will also be remotely proctored to ensure their integrity.

For applicants whose first language is not English, NEBOSH recommends a minimum English language competency of IELTS 5 (or equivalent). It is important to note that learners are not expected to have an IELTS or equivalent examination complete. Potential delegates are expected to [self-assess](#) their English language competency against the IELTS Band scores which can be found in [this](#) document.
