Learners are expected to have a foundational understanding of occupational health and safety concepts and ISO 45001 prior to attending. It is recommended that those without this knowledge complete an [ISO 45001 Foundation \(OH&SMS\)](#) course beforehand.

## What's covered?

This comprehensive two-day course focuses on the fundamentals of OH&SMS internal auditing under ISO 45001:2018.

Topics include:

### Day 1

- Introduction to OHS management systems and the PDCA cycle
- ISO 45001 and ISO 19011 standards
- The purpose and structure of ISO 45001
- Linking OH&SMS purpose to organisational context, stakeholder expectations and performance outcomes
- The Risk Assessment Process and auditing legal and other OHS requirements
- Understanding context, leadership, risks and operational planning

### Day 2

- Audit preparation, execution and reporting
- Interviewing and evidence gathering techniques
- Audit roles, responsibilities and behaviours
- Corrective actions, reporting and audit follow-up

Content is reinforced through practical exercises and can be tailored for in-company delivery.

## Who should participate?

This programme is designed for anyone involved in the auditing, management, or implementation of a Quality Management System (QMS) that conforms to ISO 45001:2018. It is equally valuable for those who are new to auditing and for experienced auditors who wish to strengthen their skills.

It will benefit individuals who:

- Conduct, plan, or support internal audits of a OH&SMS
- Manage, maintain, or implement ISO 45001:2018 OH&SMS systems
- Need to identify and address gaps in system effectiveness to support compliance
- Carry out supplier or external audits on behalf of their organisation

Typical participants include Health & Safety Managers, Co-Ordinators and Supervisory staff, Department Managers and personnel responsible for supplier or process audits.

## What will I learn?

On successful completion of this course, learners will be able to:

- Explain the purpose and structure of ISO 45001 and ISO 19011 within the PDCA framework
- Describe the responsibilities of an internal auditor in planning, conducting, reporting and following up an internal OH&SMS audit
- Prepare audit documentation including checklists and audit plans
- Conduct effective internal audits, including evidence gathering and interviewing techniques
- Evaluate compliance with OH&S policy, procedures and legal requirements
- Communicate audit findings clearly and constructively
- Contribute to the continual improvement of occupational health and safety management systems

These outcomes ensure real-world audit competence that drives improvement in workplace settings.

## What are the entry requirements?

**Important:** Learners should have the following prior knowledge before attending this course:

- Basic knowledge of the Plan-Do-Check-Act (PDCA) cycle
- Basic knowledge of how health and safety risks are identified, controlled and kept in line with legal requirements.
- Awareness of common OH&S legislation
- Understanding of key ISO 45001 terms and definitions
- Understanding of the requirements of ISO 45001

This prior knowledge may be gained by completing an [ISO 45001 Foundation \(OHSMS\) CQI & IRCA](#) training course or equivalent.

English Language Competency

A good standard of written and spoken English is important to engage effectively with this programme.

## How will I be assessed?

Learners are **assessed continuously** throughout the course via interactive exercises and engagement in Q&A sessions:

- Role playing audit scenarios
- Involvement in case study exercises
- Active participation in course discussions
- Tutor-led evaluation of individual contributions

Full attendance and participation are required for successful completion.

Successfully completing this course fulfils one of the key training requirements set by CQI IRCA for individuals seeking certification as an Internal OH&SMS Auditor.
