Organisations across all industries are under increasing pressure to prioritise employee health & safety while meeting legal obligations. ISO 45001:2018 offers a structured framework for improving occupational health and safety, replacing the previous OHSAS 18001 standard.

This one-day course introduces participants to the structure, terminology and key requirements of ISO 45001. The standard follows the Annex SL format, a universal framework that standardises structure, core text and terminology across all ISO management system standards. This alignment simplifies integration with other systems and ensures consistency in implementation across various disciplines. Learners will gain clarity on how to implement a health and safety management system (OH&SMS) that aligns with both legal and strategic goals.
