## What's covered?

This practical one-day programme covers the key principles of sustainability and their direct application in workplace contexts.

### Key topics include:

- Understanding sustainability and its organisational relevance
- Environmental, Social and Governance (ESG) risks and opportunities
- Environmental impacts and potential risks
- Compliance obligations and business drivers for change
- Benefits of improved sustainability performance
- Pollution prevention techniques and best practice
- Environmental management systems and their implementation
- Everyday actions employees can take to embed sustainability

## Who should participate?

Assessment consists of:

- Completion through the ISEP assessment portal
- A required score of 70% to pass
- A set timeframe to complete the test after registration
