What's covered?

- Identify effective communication channels for engaging stakeholders in sustainability initiatives.
- Implement change management principles and evaluate engagement strategies using environmental management systems.

Learners will gain the confidence to apply these outcomes in practical workplace scenarios, ensuring immediate and long-term benefits.

How will I be assessed?

This course is ISEP certified, with successful learners receiving an official certificate from the Institute of Sustainability and Environmental Professionals (ISEP).

Assessment consists of:

- A 20-question multiple-choice online test
- Completion through the ISEP assessment portal
- A required score of 70% to pass
- A set timeframe to complete the test after registration
